

## Oxfam Trailwalker Participant's Letter of Affidavit ("this Letter")

This LETTER should be submitted by all taking part in the Oxfam Trailwalker Event ("the EVENT"). Please note that this is a legally binding document that may affect participants' rights. Participants submitting this LETTER will be deemed to consent to its content and conditions set by Oxfam in Korea concerning the EVENT.

**I, as an EVENT participant, hereby consent to or accept the following, and fully understand the substance of each item below.**

### **1. Basic matters about the participation**

- ①. I intend to take part in the EVENT, and fully understand its purpose as a fund-raising event.
- ②. I accept the value of "a fair world without poverty" pursued by Oxfam and the initiatives conducted through a fund-raising event like this.
- ③. I respect the dignity of all individuals taking part in the EVENT, volunteers, and staff members and the values/ principles upheld by them. I will always act responsibly, adhere to dignified language and behavior, and will not discriminate against anyone on the basis of gender, sexual orientation, race, religion, ability, etc. at all times concerning the EVENT.
- ④. I understand that all my acts concerning my participation in the EVENT will be governed/ regulated by this LETTER. All matters concerning my registration for and participation in the EVENT and any disputes with the EVENT host will be handled per the laws of the Republic of Korea.
- ⑤. I understand that my registration for the EVENT will be non-transferrable to another person for the sake of the EVENT's proceedings as planned and participants' safety. I also understand that an attempt made by a person to take part in the EVENT on my behalf and under my name, will result in its cancellation without refunding payments, forfeiture of any future eligibility to take part in such an event, and invalidation of all records concerning it.

### **2. Participants' personal information**

- ①. I hereby consent to the EVENT host's collection, storage, and use of my personal information in connection with the need to handle matters concerning funds raised during the EVENT, with my consent already given at the time of online application for participation in the EVENT. I understand that such collection, storage, and use of my personal information is legitimate under the relevant law.

### **3. About the nature of the fund-raising event**

I hereby understand the following.

- ①. That the EVENT is a fund-raising event and each team of participants is asked to pay at least KRW 500,000 a year in addition to the participation fee to contribute disaster relief or international development programs led by Oxfam based on its vision of a fair world without poverty.
- ②. That all funds raised directly or indirectly through people's participation in the EVENT are spent for disaster relief or international development programs led by Oxfam. I will not use my participation in the EVENT for any purpose including fund raising not stated in this LETTER.
- ③. That any funds raised during the EVENT will be fully spent for a purpose stated in this LETTER in and will not be refunded to the donor under any unforeseen circumstances resulting in a postponement or cancellation of the event.

#### **4. Use rights to images/ recorded audio**

- ①. I hereby consent that my or my team members'/supporters' image and audio may be used for the EVENT-related PR or other activities or relevant records (including photos, films, videotapes, etc.). [A person not consenting should contact the Oxfam Secretariat.]

#### **5. Participants' health condition and doctor's opinion on their health**

- ①. I hereby confirm that I am physically healthy enough to take part in the EVENT based on my medical checkup.
- ②. I hereby confirm that a medical doctor certifies that I have no medical reason that would cause me to not take part in the EVENT.
- ③. I hereby confirm that I am not susceptible to a particular health problem including a heart-related condition and that I have never suffered from a disease related to the cardiovascular/respiratory system, brain, cancer, diabetes, high blood pressure, anemia, epilepsy, asthma, etc. I understand that if I am suffering from any of the above-mentioned, I should not take part in the EVENT, and so I shall not hold the EVENT host responsible for any health problem happening to me during the EVENT.
- ④. I will do whatever I can not to do harm to the other participants in the EVENT, and hereby confirm that I am physically fit enough to take part the EVENT.

#### **6. Safety-related promise, indemnities, and compensation**

- ①. I fully understand the risks associated with participation in the EVENT, and will take all precautions to prevent loss (e.g. death, injury, property damage, economic loss) from occurring. I also hereby confirm that I will not hold responsible the EVENT host, sponsors, relevant organization and entities in charge of medical service, catering, logistics/ material supply management, information technology, as well as other EVENT-related services (including but not limited to their representatives, employees, agents, etc.) for such an incident during preparations for the EVENT, the EVENT proceedings, and after or while moving for the EVENT. I also consent that I shall be asked to bear additional costs attributed to me to be incurred by the EVENT host

concerning the EVENT. I also recognize a possibility that the EVENT host may cancel the EVENT at any time for an unforeseen reason.

- ②. I will fully review all EVENT-related data/materials that I receive, and observe all the process, rules, and policies (including what is stated in the EVENT-related booklets) set by the EVENT host. And I will observe all relevant traffic regulations.
- ③. I understand that the relevant information provided by the EVENT host may have some flaws and that the EVENT host cannot guarantee participants' safety associated with force majeure or other risks. I understand that I cannot expect the EVENT host to remove all risk factors, and that I may ask the EVENT host questions about relevant risks and what activities the host engages in to prevent them.
- ④. I hereby consent that, in the event of a necessity, the EVENT host (including its employee, representative, contractor or a relevant one in medical service) may take me to a medical facility for health treatment. I will bear the expense that occurs for such transportation and treatment for me. I also consent to their disclosure of my medical information/records for treatment, reference and payment.
- ⑤. I hereby consent that the EVENT host may exercise its inherent right/ discretion for the following at any time: blocking my participation in the EVENT; refusal to accept a participant's registration, special registration, participant's disqualification. Where I cannot depart or should depart belatedly due to reasons of health or a personal emergency, I will bear all relevant costs. Where I need to abandon my participation in the event, I will observe the relevant procedure and regulations stated in the homepage ([www.oxfamtrailwalker.or.kr](http://www.oxfamtrailwalker.or.kr)).
- ⑥. I understand that the EVENT host may exercise its inherent right at any time to cancel or postpone the EVENT for an internal or external reason including but not limited to force majeure (e.g. gust, storm, hail, typhoon, tornado, earthquake, flood), terrorism, fire, strike, labor dispute, civil unrest, war, disaster, unavoidable accident, conditions in the EVENT course, or a cause beyond the EVENT host's reasonable control. In such a case, I understand that my donation to Oxfam is completed with my payment thereof to the EVENT and the donation I paid will not be returned or cancelled, or I can choose to put the donation as a fee for next year's event. I also understand that where I choose to take part in next year's event, a separate process of fund raising will proceed.
- ⑦. I understand that I may be get compensated concerning an incident caused by the EVENT host's error per terms and conditions of sports-related safety insurance from the EVENT-related insurance that the EVENT host is purchasing and that such insurance will not cover personal illness, health problems or an incident due to my negligence. I will take care to refrain from being involved in such an incident and understand that I may opt to purchase individual insurance for compensation concerning a personal accident.

- ⑧. Upon finding a risky spot in a particular course or facility in the course of the EVENT, I will inform the EVENT host of it immediately and do my best to help other participants not to be at risk.

## **7. Cooperative Endeavors for Environment Conservation**

- ①. Consumption of alcohol and smoking are strictly prohibited throughout the duration of all courses. Any breach of this policy will result in immediate disqualification from participation. Participants bear full responsibility for any damages incurred to the community or property, and both the community and the organizers of the EVENT reserve the right to pursue appropriate claims.
- ②. I hereby affirm my commitment to the conservation of the environment on the EVENT courses by utilizing a reusable cup and managing any waste generated by my actions.

- ☐ Hereby I confirm that I, as a participant of 2020 Oxfam Trailwalker, am responsible for the safety of my team members, have completed CPR training in advance to the event, and learned how to perform CPR in an emergency situation.
